The CSN Student Conduct Code has become outdated in light of the *Rules of Conduct and Procedures for Students of the Nevada System of Higher Education* adopted by the Board of Regents in 2013. Therefore, pursuant to the discretion afforded to the President under the current policy, I rescind the CSN Student Conduct Code in its entirety effective April 1, 2015. Upon that date and until further notice, the College will adopt and adhere to the NSHE policy referenced above as set out in NSHE Code, Chapter 10.
